a. 6 hours of classroom instruction, completion of all tests, and score 80% or better on State test.  
b. The student must have completed a Segment One course of driver education.  
c. The student must have on road experience with a parent for 30 hours or more before taking a segment two course.  
d. The student must have had a level one license for at least 3 months before taking a segment two course.

**REFUND POLICY:** This is used only if you join the course and then decide to drop out of the course. This refund policy will be used:  
a. Up to the first day of class: 100% of all money paid is refundable.  
b. During the first three classes: 80% of total tuition is refundable.

**CONDITIONS OF INSTRUCTIONS:** For a student to participate in segment 2, verification must be received that the student has completed a minimum of 30 hours of driving (including 2 hours at night) with a licensed parent or guardian (or parent designee) on a level 1 license, which has been held for not less than 3 continuous months.

**COMPLETION OF INSTRUCTIONS:** After the successful completion of Segment Two, the student will be issued a **SEGMENT TWO CERTIFICATE**. This certificate will certify his or her successful completion of all requirements which are set by the **SECRETARY OF STATE** for **SEGMENT TWO DRIVER EDUCATION**.

The driver education program of the **Student Driver's School Corp.** has been approved by the **SECRETARY OF STATE** to provide a driver education course for youth under 18 years of age.

The **Student Driver's School Corp.** will provide liability insurance covering each student fully while taking the course with us.
